Damages Deposit;

A damages deposit of £100 must be paid to make the booking.

This will be returned to you once the property has been checked.

Please note that we can no longer send you a cheque but we can make a payment directly into your account.

The deposit is returned within 7 days once the property has been checked,

this may take longer during public holiday periods

Booking Details:

Immediately upon receipt of the Holiday Confirmation from the Owner, the Holidaymaker should check the details and notify the owner of any correction as soon as possible and in any event within seven (7) days; no changes can be made to the Booking after this time. The owner reserves the right to charge a holiday booking amendment fee to administer/correct any error by the Holidaymaker.

Cancellations:

The Holidaymaker should notify the Owner immediately in writing if he/she wishes to cancel the Booking. The cancellation only takes effect when the Owner has received written confirmation from the Holidaymaker. If the Booking is cancelled after the balance of the Rental Charge becomes payable, such balance shall remain payable notwithstanding cancellation.

No refunds will be given on the cancellation of a Booking by the Holidaymaker, unless the owner can obtain a new rental for same rate. If this is the case then the owner will refund up to 85% of deposit paid. The Holidaymaker should consider whether insurance cover is desirable.

Special Conditions:

Please note that under NO circumstances can playstations, X Box or any other device can be plugged into the TV in the living room. If any of the wires are tampered with - you will automatically lose your deposit. Past visitors have damaged the TV doing this and have had to replace the TV. There is a TV in Conservatory which has a HDMI Lead connected which can be used for playstations etc. **Loud Music (Audible to the resident neighbours) must not be played outside. Absolutely no music at all after 21.30.**

Hot Tub:

Please note that the hot tub must be left how you found it - and under no circumstances should anyone eat or drink in the Hot Tub. As we have had so many people abusing the Hot Tub facility - an automatic deduction of £50 will be taken if the cleaner finds food / drink trace or any other materials in the hot tub.

No more than four people in the tub at any one time. No smoking. No toys. No dogs. No sole children. No playing- in the Hot Tub.

If the hot tub is out of use due to any reason and cannot be used for any reason then a maximum refund of £50 only will be given as compensation.
